

## Urgent Action for Sur Bahir, Wadi al Hummus, July 2019

In the early hours of 22<sup>nd</sup> July 2019, hundreds of Israeli military and police entered the village of Sur Bahir, Wadi al Hummus, in south east Jerusalem - part of the occupied West Bank. They forcibly removed families from their homes using tear gas, pepper spray, sound bombs and physical force and then began the demolition of up to 10 residential apartment blocks.

Since 2009, the Israeli authorities have demolished, or forced owners to demolish, 69 structures in Sur Bahir. This has resulted in the displacement of 30 households with 400 people displaced or affected by the demolitions - half of them children under 18 years of age. Israeli authorities say the homes are too near the separation barrier, a barrier that Israeli authorities built.

The new demolition orders are for 70 apartments in inhabited, or under construction, buildings. The homes are under the authority of the Palestinian Authority - area A of the Oslo Accord - and all have building permits from the PA. The Israeli court ruled that they can be demolished on the grounds that they are too near the separation barrier. Again the demolitions will forcibly displace Palestinian families, including the elderly and children.

**Forcible Transfer of people under occupation is a serious breach of the Fourth Geneva Convention. The deportation of or transfer of all or parts of the population of the occupied territory, within or outside this territory, constitutes a war crime under Article 8 of the Rome Statute.**
